**Sub:** SLDC – Grid Operation - Implementation of TNERC’s Intra-State DSM Regulations 2019- Constitution of State Power Committee (SPC) – Nomination for the committee Members– called for – Reg.

The Secretariat of Tamil Nadu State Power Committee has been formed and is functional from 22.01.2021.

As per the directions of the Hon’ble TNERC vide DSM Regulations 2019 and subsequent approved implementation procedure dated 03.10.2020, the Tamil Nadu State Power Committee (TNPSC) shall have to be constituted with representatives from SLDC, TANGEDCO, TANTRANSCO and Private generators with installed capacity more than 100MW.

The criteria for the selection of Members for the SPC has been stipulated in the TNERC approved procedure which is detailed below.

TNSPC shall have the Members representing,

- 1) State Load Despatch Centre (SLDC)
- 2) State Transmission Utility (STU-TANTRANSCO)
- 3) Distribution Utility (TANGEDCO)
- 4) State Owned Generating Stations (TANGEDCO)
- 5) Independent Power Projects (IPPs)
- 6) Captive Generating Plants (CGP)
- 7) Wind Power Producers
- 8) Solar Power Producers
- 9) Co-Gen power plants, Bio Mass Power Plants
- 10) Traders
- 11) Qualified Co-ordinating Agencies (QCAs)
- 12) Deemed Distribution Licensees.

Wherever a member is represented by rotation, the nomination would be for a period of one year

The representative from respective organizations should be either the head of the organization or at least a person not below the rank of a Director on the Board of the Company/Corporate entity except for Central Public Sector undertakings (CPSUs) where representative could also be at the level of Executive Director.

In order to constitute the State Power Committee, representatives from stake holders as explained above have to be enrolled as Members of TNSPC. Accordingly, nomination from the following may be indicated:

- i. State Load Despatch Centre  
(Chief Engineer/Grid Operation)
- ii. Tamil Nadu Transmission Corporation Limited  
(Director/Transmission Projects and Director/Operation / Authorised representative not below the rank of Chief Engineer)

- iii. Tamil Nadu Generation and Distribution Corporation Limited  
(Director/Distribution / Authorised representative not below the rank of Chief Engineer)
- iv. State Owned Generating Stations  
(Director / Generation / Authorised representative not below the rank of Chief Engineer)
- v. Independent Power Projects  
(Members from IPPs with installed capacity more than 100MW)
- vi. Private Generators  
(Members from the Generators with installed capacity more than 100MW).
- vii. Wind Power Producers  
(Members from the producers with total installed capacity of more than 100MW)
- viii. Solar Power Producers:  
(Members from the producers with total installed capacity of more than 100MW)
- ix. Co-gen power plants, Bio mass power plants  
(Members from the producers with installed capacity of more than 100MW)
- x. Traders  
(Members from the Traders with trading quantum of more than 100MW)
- xi. Qualified Co-ordinating Agencies (QCA)  
(Members from the registered QCA)
- xii. Deemed Distribution Licensees  
(Members from Deemed Distribution Licensee if any).
